You may also have further questions to ask us.

5. If, after all your questions have been answered, there is a mutual agreement in proceeding with a formal application for an Exeid Franchise Licence, we'll ask you to sign an Intent to Proceed agreement and pay a deposit in order to secure your Franchise territory.
